Release of Liability Please Initial and Sign

I acknowledge I am voluntarily participating in this activity involving horses with knowledge of the danger involved, also that I am voluntarily participating in events with horses and that they are unpredictable. I ASSUME ALL RISKS, KNOWN & UNKNOWN, OF PARTICIPATING IN EVENTS INVOLVING HORSES, & AGREE TO HOLD HARMLESS THE VSGC, CGA, CITY OF SAN MARCOS, FALLBROOK, & OTHER ARENA OWNER(S).

___ I release the VSGC, CGA, City of San Marcos, Fallbrook, & their officers, board members, members, volunteers and arena owners from any & all liability for any act of negligence or want of ordinary care on the part of the organization or any of its agents. In consideration of my participation in events organized/sponsored by the VSGC, City of San Marcos, Fallbrook, CGA and the arena owners in which their gymkhana shows are held. I waive, release & discharge, the VSGC, CGA, their directors, officers, member/agents, representatives, heirs, executors & assigns, as well as arena owners, from any & all claim or liability for injury, damage to myself, mount, or property arising out of my participation. This agreement is binding on my execution, heirs and assigns.

___ I expressly waive the rights I may have under the California Civil Code 1542 which states "a general release does not extend to claims which the creditor does not know or suspect to exist in his/her favor at the time of executing the release, which if known by him/her, must have materially affected his settlement with the doctor."

___ I agree that I will defend, indemnify, & hold harmless the VSGC, CGA, their officers, directors, members, & agents against any & all claims, demands and causes of action, including court costs & actual attorney fees, arising from any proceeding/lawsuit brought by or prosecuted for my benefit, in which this release is upheld.

___ I acknowledge that I have read this RELEASE OF LIABILITY, and know & understand its contents, & I the undersigned parent/guardian/chaperone or the minor children in my family as listed above, in consideration of the child's participation in the event, agree that the terms & conditions of the Release of Liability shall be binding as to damage or injury to my child/children, mount & property, arising out of their participation in the event.

___ I have carefully read this agreement and acknowledge that this is a release of liability & a contract between myself. The VSGC, CGA, City of San Marcos, Fallbrook, and that I fully understand the contents of this release of liability, & that I am of sound body & mind, & am signing this contract of my own free will.
